We have strengthened our verification and payment procedure during the year under review to ensure the transparency at maximum level. We have adopted the system in such a way that 90% payment directly made to furniture manufacture and catering & venue vendors whereas 10% portion has been paid to applicant(s).

MEDICAL AID:-

Mr. Amin Siddiq Panawala chaired the Meetings of Medical Aid (Outsource) and he along with Mr. Farhan Motiwala, Mr. Sohail Abdul Shakoor Moten, Mr. Amanullah Zakaria Moten, Mr. Abdullah Abdul Razzak Chara extended the facilitations on account of medical care and procedures to our needy jetpurians at different hospitals outside Fatima Bai Tai Hospital (FBTMH).

Mr. Irfan Abdul Ghaffar Andha (Chicha) along with Mr. Farhan Motiwala, and Mr. Amanullah Zakaria Moten look after the Medical Aid being provided at FBTMH. During the year, JMA spent historic amount on account of medical aid to meet the high cost of treatment and surgical procedures Provided more than 1300 + Families in Medication & Treatments from various Hospital like Kutiyana, Aga Khan, Liaquat National, Tahir Medical, Darul Sehat & Al Tamash (50% from Donation) through FBTMH, Tabba Heart Institute (THI), Tabba Kidney Institute (TKI) Patel Hospital, Memon Medical Institute (MMI) and other Hospitals who contributed through their welfare as well. We have contributed 25% to 30% share towards cardiac treatment and dialysis treatment at THI and TKI whereas in other hospitals we have fixed the limit of Rs. 200,000/- per patient, nevertheless, we have spent the amount exceeded Rs. 200,000/- in some long stay cases due to complication and critical conditions of the patient.

We have also issued welfare medical cards to our needy Jetpurain families who have registered themselves in FBTMH so that they can come at any time to avail the medical facility there. These welfare cards are also valid in MMI for any emergency situation. We have also developed entire data base of our welfare beneficiaries in respect of medical aid in FBTMH. In Future JMA is planning an Ambulance Services for Community people.
